This will allow the ability to pay for health care after retirement. The attorney is very familiar with the IPPFA post retirement program.

- The new rescue engine is now in service as well as Peotone's new engine
- The Station location study is done and will be discussed further at a later date.

- -Received a \$7,500 grant to purchase a thermal imaging camera. Waiting to hear back on other grants that were applied for.
- -In the process of hiring 4 part time employees to replace those that recently left for full time positions elsewhere.
