Station 81 and Station 82 both have griddle tops for cooking. With the current remodel it was discussed that station 83 would benefit from the same set up.

Subject: Station 83 Kitchen Island

Discussion was had about assisting with the cost of a kitchen island for station 83. Chief Malone explained that the budget for the remodel covered a custom kitchen table. It was later discussed with members that a kitchen island like Station 81 and Station 82 would be beneficial. The island would have stone top and cabinetry below it. We are looking to pay the difference in what a table would have been. After reviewing the table prices from the recent purchase of the bay tables we would be paying approximately \$6000.
